The meeting was called to order by Supervisor Louis Sturm at 7:00pm. The pledge of allegiance was cited and the agenda was read. In attendance were Louis Sturm, Amy Hebzynski.,Lori Turri, Rick Smaniotti. Motion to excuse Chuck Adams made by R Smaniotti; supported by L Sturm

CENTRAL UP RALLY: Heard from residents T Hines, B Hanselman, R Cappocia, and J Gleason against the Central UP Rally. These residents were not informed about the event. According to R Van Damme only those in the “hot zone” were notified which were mostly camps. Those against cited safety, noise, wild life and road closure concerns. R Van Damme, organizer, answered questions from the residents. After lengthy exchanges a motion was made by A Hebzynski to deny the race “permission” to utilize Waucedah Township roads with the exception of the small parcel near the intersection of Browns Lake Rd & Norway Truck Trail in which the route passes through (near Lyons Lake Rd); supported by L Sturm. ROLL CALL vote to deny primary usage with small intersecting exception was unanimous. Note: L Sturm to follow up with DCRC regarding race concerns. R Van Damme stated that the UP Central Rally can alter the race course
